We have noticed an inadvertent error in our article entitled “Overlooked diversity in Brazilian *Cypella* (Iridaceae: Iridoideae): four new taxa from the Río de la Plata grasslands” (*Phytotaxa* 174 (1): 25–42).

The published Figure 4 includes one image (Fig. 4D), which was misidentified as *Cypella amplimaculata* Chauveau & L.Eggers (2014: 29), but actually belongs to *Cypella herbertii* (Lindley 1825: t. 949) Herbert (1826: t. 2637) subsp. *herbertii*. A corrected version of Figure 4 is currently attached with the appropriate image. This error does not change the scientific conclusions of the article in any way. The authors apologize for this error.

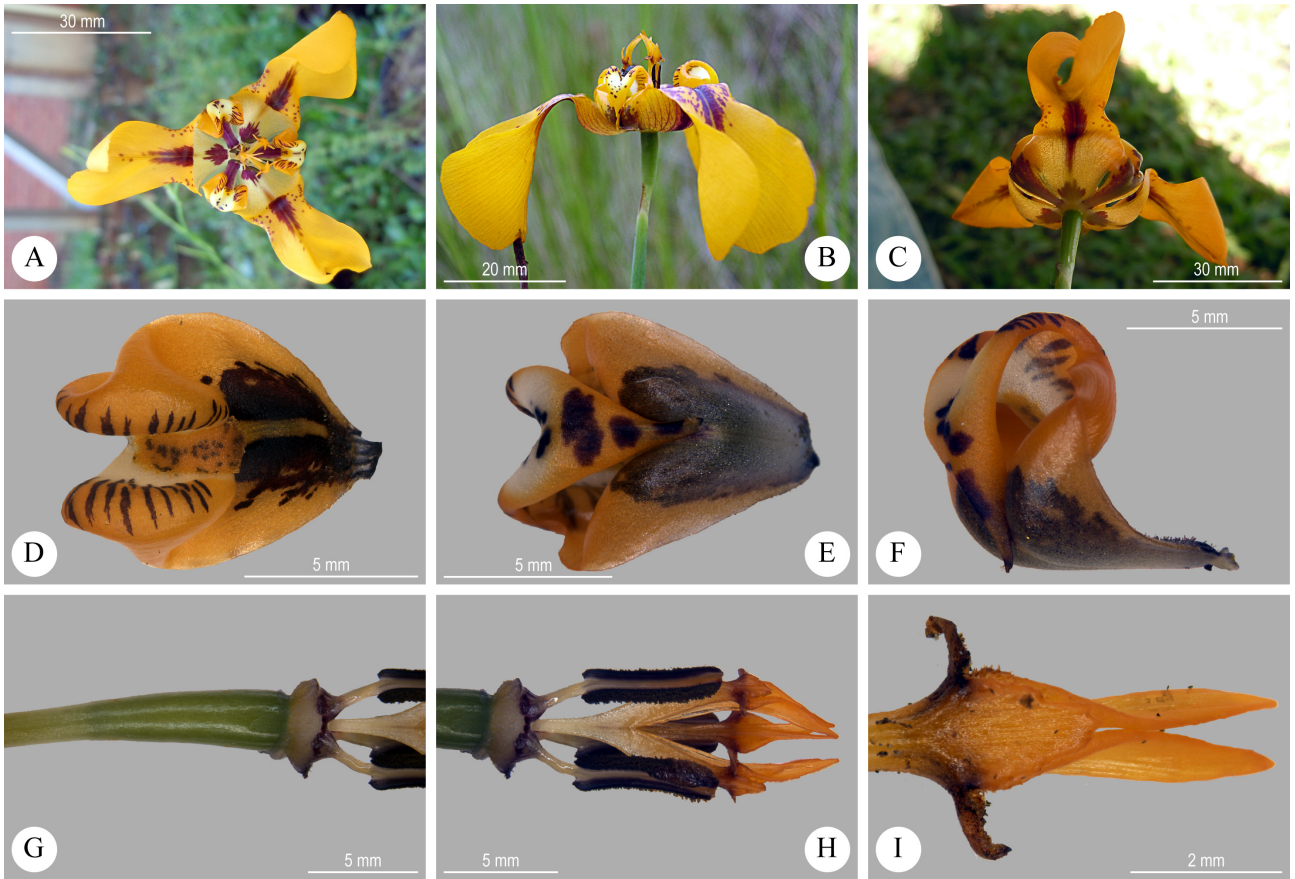
