Huang, Q.L., Fei, W.Q., Yuan, Q. & Yang, Q.E. (2024) *Clematis armandi* var. *kiangnanensis* (Ranunculaceae) is not synonymous with *C. armandi*, but *C. finetiana*, a widely distributed species in China. *Phytotaxa* 660 (3): 259–277.

Please note that (1) two sentences in the Introduction on page 259 should be, respectively, as follows:

Wang (2003), when placing *C. armandi* var. *kiangnanensis* in synonymy with *C. armandi*, cited three Jiangsu collections, *F. Courtois* 7186, 21042, 21120, as syntypes of *C. armandi* var. *kiangnanensis*.

In 1999, he correctly identified a flowering specimen of the collection *F. Courtois* 25866 (P; Fig. 1A) as *C. finetiana* on the determination slip.

Not as:

Wang (2003), when placing *C. armandi* var. *kiangnanensis* in synonymy with *C. armandi*, cited three Jiangsu collections, *S.J. Courtois* 7186, 21042, 21120, as syntypes of *C. armandi* var. *kiangnanensis*.

In 1999, he correctly identified a flowering specimen of the collection *S.J. Courtois* 25866 (P; Fig. 1A) as *C. finetiana* on the determination slip.

Notes:—The authorship of the paper “Le *Clematis* de la province de Ngan-hoei (Chine). *Bulletin de la Société Botanique* 72: 422–445” was given as “P. COURTOIS S. J.”. In the course of preparing the manuscript of our paper “*Clematis armandi* var. *kianganensis* (Ranunculaceae) is not synonymous with *C. armandi*, but *C. finetiana*, a widely distributed species in China. *Phytotaxa* 660 (3): 259–277”, although we correctly understood that “P.” is the abbreviation of “Père”, we misunderstood “S. J.” as the abbreviations of the first and middle names of the author of the former paper and also the collector of most of the type specimens of the name *Clematis armandi* var. *kianganensis*. Actually, “S. J.” is the abbreviation of “la société de Jesus (= Society of Jesus)”. The author of the former paper, F. Courtois, once served as the director of the Zi-ka-wei (Xujiahui) Museum founded and run by the Society of Jesus in Shanghai, China.
